Joining Eos and PRS

If you are a composer, an author or a publisher of music and you wish to receive royalties for your works you need to join Eos and PRS. Eos will collect radio and television broadcast royalties on your behalf, and PRS will collect other royalties such as live performance, on-line use and international use.

As PRS collects data on behalf of Eos, if you are not a member of PRS, PRS will not collect data on the use of your works and therefore Eos will not know how much to pay you. At present, PRS charge a membership fee of £100. Eos does not charge a membership fee at present.

Once you have completed the form you will need to print it, sign it and send it through the post to PRS. You will also need to print and enclose the letter below with your PRS membership form. You need to add your address and signature to the letter.

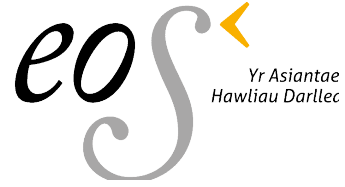

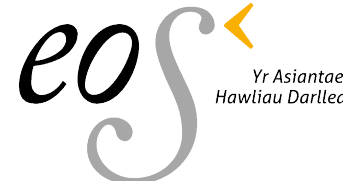
